As a Certificate of service is included.

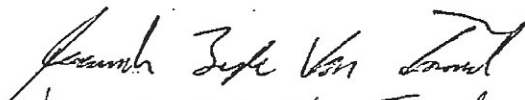
WHEREFORE, for the foregoing reasons, the
